

Consent Agreement



The Recovery Capital Index® (RCI) is a survey that tracks and measures recovery capital. Your completion of the survey will aid yourself and the peer recovery specialist in understanding your needs, your progress, and how well you are doing in Opioid Treatment Court. The RCI Platform used by **TREATMENT PROVIDER NAME** delivers the RCI primarily by text message, but also manages and analyzes the RCI data, results, demographic data, and text message content provided by you. The Platform is only accessible by the peer recovery specialist at **TREATMENT PROVIDER NAME**. The RCI and other questionnaires will be used to evaluate the effectiveness of peer support services provided and your participation in the Opioid Treatment Court. Your responses to all questionnaires will be anonymized and aggregated for program evaluation.



Data & Privacy

The data you provide through the RCI is your data. You may decline or stop providing your information, ask for your data, or ask us to destroy your data at any time. We may only use your data to provide peer support services, determine quality and effectiveness, and improve the RCI. Your data will never be shared without your express permission.



Communications

The RCI is a self-report survey completed through a secure web link. We use automated technology to send that link and other related messages to you by SMS/text. We will only communicate the survey, results, and messages related to services delivered by the peer working in Opioid Treatment Court.

BY PRINTING AND SIGNING YOUR NAME BELOW, YOU UNDERSTAND THAT THE RECOVERY CAPITAL INDEX IS NOT A DIAGNOSTIC TOOL BUT A SELF-REPORT SURVEY TO HELP PROVIDE PERSONAL INSIGHT, CERTAIN SERVICES, IMPROVE THE QUALITY OF CARE, OR ADVANCE KNOWLEDGE THROUGH DATA ANALYSIS. BY PROVIDING YOUR MOBILE PHONE NUMBER YOU CONSENT TO THE AUTOMATED DELIVERY OF THE SURVEY, OTHER RELATED QUESTIONNAIRES, AND PROGRAM-RELATED MESSAGES TO YOUR PHONE VIA SMS. YOU CONFIRM THAT YOU ARE SIGNING THIS CONSENT VOLUNTARILY AND YOU UNDERSTAND YOU HAVE THE RIGHT TO REVOKE YOUR CONSENT AT ANY TIME. REVOKING CONSENT TO THE RCI DOES NOT IMPACT ANY OTHER CONSENT OR DELIVERY OF SERVICES BY **TREATMENT PROVIDER NAME**. YOUR IDENTIFIABLE INFORMATION WILL BE HELD CONFIDENTIAL AND ONLY ACCESSED BY **TREATMENT PROVIDER NAME** AND AUTHORIZED STAFF. THE RECOVERY CAPITAL INDEX IS PROVIDED AND MANAGED BY **COMMONLY WELL, PBC**, WHO MAY ACCESS YOUR INFORMATION FOR MANAGEMENT AND SECURITY PURPOSES AND MAY USE YOUR DE-IDENTIFIED DATA FOR THE ONGOING IMPROVEMENT OF THE RECOVERY CAPITAL INDEX AND TECHNOLOGY SYSTEMS. YOUR DE-IDENTIFIED DATA WILL BE PROVIDED TO **RULO STRATEGIES** FOR PROGRAM EVALUATION OF PEER SUPPORT SERVICES PROVIDED WITH YOUR PARTICIPATION IN OPIOID TREATMENT COURT.
